QUESTION: "How do I find a barefoot trimmer?"

I have talked with 3 different farriers and they said that if you board try the farrier that comes to the barn, ask him questions regarding the trimming and see how he handles the horses. If you are satisfied with what you see and the answers he gives then you go with him. If not then you ask around and find someone that way. All 3 stated that all horses are trimmed barefoot and when trimmed the hoof should naturally be balanced. The only extra the farrier should charge would be if your horse needs shoes. **Beverly**

John Freiburger gave a report on the current status of the ADS. He encouraged HUB Club and other driving events and venues to continue to apply for grants to keep this function.

Sponsorship Committee

Lydia Gray reviewed which events we sponsored in 2016 and how much money was given to each event and also indicated which events we are considering adding to our list of sponsored events in 2017. She then asked the membership for a budget. Carolyn Sluiter made a motion that as a standing order we use a maximum of 75% of our membership dues towards event sponsorship. Sue West made the amendment that in 2017 we use a flat

USEF Board Of Directors Removes American Driving Society As Recognized Affiliate

The U.S. Equestrian Federation announced in a press release Jan. 20 that the American Driving Society will no longer be recognized as the driving affiliate.

"The change in recognition results from an inability to reach an agreement as to the responsibilities of the Recognized Affiliate for the driving discipline," the release stated. "The USEF Board of Directors conducted a thorough review regarding the status of a draft affiliate agreement during the recent USEF Annual Meeting. This included a historical review of the work of ADS to meet its responsibilities as a USEF Recognized Affiliate and the specifics of the draft agreement. After considerable work with the ADS to reach an agreement, the USEF and the ADS remained at an impasse."

Mike Arnold, president of the ADS, said the board of directors made the decision during a closed session, which neither he nor any other member of the ADS was allowed to attend, and that the USEF notified them of the decision in a letter. "We were really upset and dismayed that I wasn't able to be in there to represent ourselves and represent the ADS," said Arnold. "In the end, [the decision] was about a few people. They somehow left the driver out of it, which is all we're really concerned about." The decision was made after USEF approached the ADS about restructuring the relationship between the two. "A year ago, the board met and said, 'You've got a year to work it out and get into compliance with the federation policies and procedures—especially around drug testing and licensed officials,' " said USEF President Murray Kessler. "They went through that process and had mediators [Joseph Mattingly, chair of the International Disciplines Council, and Pete Kyle, member of the IDC] involved, but at the end of the day, they were unable to come into a level of compliance that made us feel comfortable with the governance and our responsibilities for governance. "This is not a decision that was taken lightly," Kessler continued, "but just like how I want the organizers and competitors to operate in a fair and level playing field, we need to do the same as a federation." The decision will not impact aspects of driving that already fall under the USEF purview, including the selection of championship teams. Pleasure driving will be unaffected, because there are no joint USEF-licensed/ADS-recognized shows in that division. However, combined driving does have roughly four to eight dual-licensed events per year, which will be affected. The ADS traditionally has jurisdiction over training, preliminary and intermediate competitions, while USEF is in charge of advanced and any FEI-sanctioned competitions. It's not so much a problem for the lower level, but what does it mean for the upper level?" asked Arnold. "I fear that it's just not good for the sport. I fear it's going to further restrict those advanced competitors to the more wealthy, and we've worked hard to prevent that." While Arnold said the ADS was willing to make concessions on certain points of contention, such as drug testing by 2020, they felt strongly that the licensing of officials should be kept under their umbrella. "For more than 40 years, the ADS has been training and licensing officials for the lower levels, as well as for USEF-licensed competitions," said former ADS President Natasha Grigg, who was also a member of the working group tasked with negotiations. "Any person who wished to become a USEF official, all they had to do was join USEF and go through the [licensing of officials] USEF requirements. They were encouraged to do so; obviously we need USEF 'R' officials to judge advanced competitions. It's never been a problem. There has historically been very little connection between USEF [Licensed Officials Committee] and ADS LOC. It's probably everybody's fault, but there has been a disconnect."

All current USEF carriage pleasure or combined driving officials must participate in a USEF Licensed Officials clinic, or take an exam to maintain a license. Any officiating maintenance requirements must now be met with USEF, and USEF liability protection will not cover officials at ADS competitions.

Temperature Swings Increase Risk of Colic in Horses

As winter sets in, notable temperature swings have occurred in many areas of the country. Perhaps it's 50° F during the day but drops to 25° F at night, or sunny and mild one day but snowing the next. Horses are notorious for colicking under these conditions, but horse owners can minimize this through simple management strategies. It may seem obvious, but providing access to fresh, unfrozen water is essential for proper hydration and digestion. The more horse consumes, the more water required to help move it through the gastrointestinal tract. This is especially important in winter when moisture-rich pasture grass is limited or absent. Offering free-choice salt or adding a little salt or electrolytes, especially a slow-release electrolyte supplement like Restore® SR, to a horse's ration will encourage a horse to drink and assist in keeping a horse adequately hydrated,

minimizing colic risk. Another key to helping a horse stay hydrated is to provide plenty of forage in the form of hay or pasture grasses because the presence of the fiber in the gut will stimulate the thirst response. Additionally, microbes in the hindgut ferment the structural carbohydrates, or fiber, in hay or grass. Heat is a byproduct of fermentation, which helps keep the horse warm. For this reason, extra hay (and water, of course) should be offered when temperatures are expected to drop. Note that grain concentrates will not have quite the same hydrating or warming effect. Exceptions would be commercial feeds high in beet pulp or standalone soaked beet pulp, which will have a similar effect as forage. When temperatures drop, it's not unusual for training regimens to diminish and for turnout time to decrease. Exercise and movement, even if just walking around a turnout area, promotes gut motility. When horses are confined for long periods due to inclement weather, the risk of colic increases. Keep horses moving and turned out as long as the footing is safe. With this in mind, for horses that live outside, shelter is critically important for protection from the elements. If a horse's coat or blanket becomes wet, the risk for chill increases dramatically and could trigger a bout of colic. Be sure to check in on your horses, especially in inclement weather. The use of a digestive-tract conditioner such as EquiShure® or RiteTrac™, products designed by Kentucky Equine Research, helps minimize the risk of colic. EquiShure is a time-released hindgut buffer. That acts on the cecum and colon by minimizing the effects of subclinical hindgut acidosis. RiteTrac contains a blend of ingredients to support healthy function in both the foregut and hindgut. In summary, remember the basics. The importance of water cannot be overstated in helping a horse stay healthy and hydrated. Good-quality forage is essential for warmth and proper gut motility. When drastic temperature changes are predicted, pay extra attention to a horse's behavior. Any subtle changes could indicate a problem. Call your veterinarian immediately if you suspect colic or any health issue.
